The meeting was called to order at 7:07 p.m. by President Carlsson.

BE IT RESOLVED that the matters discussed in closed session will be disclosed to the public as soon as and to the extent that such disclosure can be made without adversely affecting the public interest or without violation of the confidentiality of personnel.

On motion by Mr. Wilke, seconded by Ms. Cwerner, and approved by all present, the Board recessed into closed executive session at 6:30 p.m.

On motion by Mr. Koch, seconded by Ms. Sherwyn, and approved by all present, the Board returned to public session at 7:00 p.m.

The Board reconvened the regular meeting in the Oak Street School Auditorium at 7:00 p.m.

IV. Regular Session – Call to Order – 7:07 p.m. – Oak Street School Auditorium

V. **Statement of Public Notice**

This was a regular meeting of the Board of Education of Bernards Township. Notice of the time and place of this meeting was provided and copies of that resolution were forwarded to the official newspapers as designated by the Board of Education and to the Township Clerk and a copy of the notice was posted on the bulletin board of the Board of Education Offices in accordance with P.L. 1975 Chapter 231A.

We very much welcome input from the public. There are two times during regular meetings that the public is invited to speak. One time is early in the meeting before the Board votes, and you may speak about any item that is listed on tonight's agenda. Towards the end of the meeting, there is another public forum to address any topic whatsoever.

When you approach the microphone, please state your name and address. We do not have a specific time limit, but we ask that you keep your comments brief. Please understand that our public forums are not structured as question and answer sessions, but rather they are offered as opportunities to share your thoughts with the Board. In instances where the Board feels that there is a misunderstanding or inaccuracy, a member of the Board or Administration will address it in the Board Response portion of the agenda.

There are times when a member of the public makes a comment or asks a question about an employee. New Jersey statute does not permit us to discuss personnel issues in public. Also as a matter of law, a Board of Education may only vote for or against the hiring of an employee upon the recommendation of the superintendent. If the superintendent does not recommend a person, that person's name is not listed on the agenda and there is no vote on that action.

If it is necessary for the Board to go into executive session at the end of the meeting, we will provide an estimated length of time for the session and whether any action is anticipated to be taken upon returning to public session.

VI. **Student Representative**

Student Representative Kathleen Kirk spoke on the success of the recent Mr. Ridge contest with monies from the event being donated to the Fern Wilson Memorial Fund and Project Graduation. The Junior Class Fashion Show fundraiser has been held for several years and while extremely successful, a new type of show is being considered for next year. Ms. Kirk mentioned the success of the student production of *Rent* calling it "amazing." For the first time ticket sales were held online. Upcoming high school

events include the Superhero half marathon with 50 volunteers from Ridge High participating, the Wellness Community Butterfly Release and 5K run with a team from Ridge High, and the National Honor Society's participation in Teen Night at the YMCA. Ms. Kirk stated the prom this year is being held at the Bridgewater Marriott on April 29.

VII. **Public Hearing 2011-12 School Budget**

1) **Budget Presentation – Susan Carlsson Board of Education President**

Ms. Carlsson reviewed last year's state aid, the decrease in state aid for 2011-12 the district was told last fall to anticipate and the actual award of \$777K in additional aid for 2011-12. She stated it is very difficult to formulate a budget, anticipate revenue and plan

for expenses when swings of this nature occur on an annual basis. Even with this extra funding, the district remains behind \$3M in state aid from two years ago.

The following items were highlighted in Ms. Carlsson's presentation of the 2011-12 budget:

- The facts (loss of \$1.6M state aid 2009-10, loss of \$3.9M state aid 2010-11, gain of \$777K aid in 2011-12, 2% tax cap, no cap adjustments to be taken and the issue of allocating the additional aid)
- The history of state aid from 2000-01 until 2011-12 (by state standards the district spends below the state adequacy level)
- Current to proposed budget
- Budget reductions from 2010-11 to 2011-12
- Proposed athletic cuts
- 2010-11 to 2011-12 spending & tax comparison
- Anticipated 2011-12 total per pupil cost
- 2009-10 total & administrative cost per pupil
- Finance Committee recommendations included: 2% cap level, no cap adjustments, 8 period day at high school, full day kindergarten subsidized by community, staffing reductions, guidance counselor at middle school and additional aid for infrastructure
- Additional state aid options

2) **Board Forum on Budget**

Board comments included the challenge of remaining within a 2% cap, priority of roof repairs, moving forward next year with Option II regardless of eight or nine period day, strength of the current high school academic program, increased time on task with an eight period day, \$3.5M in high priority capital projects, impact of utilizing the \$777K as tax relief, additional guidance counselor at the middle school, and maintaining the current

high school schedule.

Dr. Goger spoke on her concern with sustaining programs as the district goes forward with a 2% cap, and an increase in college prep class size with a nine period day as no additional staff has been hired at the high school in a number of years. If the nine period day were to remain at the high school, she recommended that four teachers (one in each core subject) be hired to help lower class size.

3) Public Forum on Budget

Comments made included use of state aid for tax relief vs. capital projects, actual time on task when projected over four years, elimination of specific athletic programs and allowing parents to fund these programs, success of online courses, tutorial programs at the high school, importance of supporting the budget, what about next year?, suggested review of projected capital projects cost, maintaining guidance counselor at high school, instituting pay to play, the elimination of world language at elementary level, and anticipated class size at middle and high schools.

VIII. Board Presentation

Solar Panels – Tony Cantana, Spiezle Architects

Mr. Cantana explained the process of a PPA (power purchase agreement) and the advantages to the district in offsetting the cost of a capital project such as the district’s needed roof repairs. The PPA will bid out the project and must come back less than the cost of the work to be done. Mr. Cantana discussed the system costs, bidding process, total kW by building, and building location and placement of solar panels. In order to make this project cost effective two of the three grounds locations need to be installed (Mount Prospect School corner of Allen & Hansom Roads, Ridge High School upper parking lot and William Annin Middle School parking lot). Spiezle Architects will receive a 5% fee of the roof work and 5 ¼% fee of solar installation.

BE IT RESOLVED THAT

The Bernards Township Board of Education does hereby authorize the school business administrator to engage Spiezle architects to take all necessary steps to put all of the roofing work identified in the District’s Long Range Facility Plan out to bid for the purpose of implementing the project work in the summer of 2011, inclusive of all required submittals to the Department of Education **for Non-Grant approval**. In addition, the school business administrator is authorized to further engage Spiezle architects to take all preliminary steps needed to develop a PPA to fund the roofing projects described here in correspondence to solar installation sites to be finalized at the April 25th Board of Education meeting. Finally, the Board directs the school business administrator to inform the Somerset County Improvement Authority that the district is withdrawing from participating in the County’s solar initiative.
